Legislative Updates

NJEDA Main Street Acquisition Support Grant

The NJEDA Main Street Acquisition Support Grant is a pilot initiative under the Main Street Recovery Fund designed to assist eligible small businesses in covering closing costs related to the purchase of a New Jersey commercial property for operational use. Each qualifying small business can receive a grant of up to \$50,000 per location. To be eligible, the applicant must occupy a minimum of 1,000 square feet of usable space in the purchased building, and all transactions must occur in an arm's length manner with a conventional lender. The total funding available for this program is \$5 million.

NJEDA Small Business Improvement Grant

The NJEDA Small Business Improvement Grant provides reimbursement for expenses incurred in making building enhancements or acquiring new furniture, fixtures, and equipment. Eligible small businesses and nonprofits can receive funding for 50% of eligible costs, up to a maximum of \$50,000. Notably, 40% of the available funds are earmarked for businesses and nonprofits located in Opportunity Zone census tracts.

NJEDA Small Business Lease Grant

The NJEDA Small Business Lease Grant aims to support the expansion and sustainability of small businesses and nonprofits by offering grant funding to offset a portion of lease payments for those leasing new or additional spaces. This program covers 20% of the total annual lease payment, providing vital financial relief to eligible organizations.

Minimum Wage Update:

TRENTON – New Jersey's statewide minimum wage will increase by \$0.36 to \$15.49 per hour for most employees, effective January 1, 2025.

Pursuant to Article 1, Paragraph 23, of the New Jersey Constitution, and N.J.A.C. 12: 56-3.1(c), the New Jersey Department of Labor and Workforce Development (NJDOL) sets the minimum wage for the coming year based on any increase in Consumer Price Index (CPI) data provided by the U.S. Bureau of Labor Statistics.
